University of Cyprus MBA Program Scholarships to Italian Citizens

We would like to inform you that the MBA Program of the University of Cyprus announces three (3) scholarships to Italian citizens for the new academic year 2017-2018, as follows:

- One (1) scholarship up to 100% of tuition fees
- Two (2) scholarships up to 50% of tuition fees

Tuition fees of the MBA Program of the University of Cyprus currently stand at 10.250 Euros.

The criteria for the above scholarships include the following:

- Italian citizenship.
- Degree from a recognized academic institution or equivalent and excellent academic performance.
- Three years of full-time work experience. Exceptional cases of candidates with less experience, who can demonstrate significant potential for leadership and superior academic performance, will be considered.
- Proficiency in the English language (this is waived for candidates who hold a degree from an English speaking institution).
- Two recommendations from academics or people who can judge the candidate's potential contribution to the Program.
- Successful completion of a personal interview with the Admissions Committee.
